



STUDENT REGISTRATION AGREEMENT

Agreement made this _____ day of _____ by and between Starfish Swim School, Inc. or assigns and **Name** (Parent's name) _____ of **(Address)** _____ whose child(ren) are enrolled in swim lessons with Starfish Swim School, (aka) Swim Schools Inc.

In consideration of the terms of this agreement, the undersigned Parent(s) agree as a condition of enrollment:

1. This Agreement shall apply to the current lessons and ANY additional lessons in which your child(ren) is enrolled in Starfish swimming lessons.
2. Cancelled or Missed classes. If the need to cancel current swim lesson arises, Starfish will **not** refund any portion of your remaining advance payment. Starfish must received 30 days advance **written notice** of your need to cancel lessons. In no event will Starfish Swim School offer any credit for classes attended.
3. Credits will be placed on your Starfish Swim School account for classes that are cancelled due to pool closures. This credit will be applied towards either a remaining balance that is due to the school or will be applied towards future classes at Starfish Swim School.
4. Cancellations for **private** swim lessons must be received 24 hours in advance to receive a partial credit for the class. Parents will be charged half of the regular private class fee to hold a class time for those enrolled in private lessons.
5. The current tuition for each class lesson for which your child(ren) is/are enrolled is set prior to the start of each month. In addition to the fee for tuition, you are charged a **non-refundable** annual administration fee of **\$25.00** per child (with a family maximum of **\$50.00**). This fee covers various expenses including pool use time, equipment use and maintenance, administrative costs and liability insurance for each child's participation in a Starfish Swim School class session. The last item is subject to the waiver being signed and returned.
6. Payment must be received at the time of registration. Your child will *not* be confirmed into a class without it. Parents that make late tuition payments shall be subject to a surcharge of up to thirty dollars (**\$30.00**) per month and/or all reasonable collections costs and interest if it becomes necessary. In addition, Parents are charged a **\$25.00** fee for any returned check, and \$10.00 for on declined automatic debit transactions.
7. **No Makeup Classes**. Sorry - we do not offer makeup classes, give credits or offer a refund for any class which your child missed. Our staff is present for every scheduled lesson, whether your child is in attendance or not. Starfish classes are designed for each student based on level, content and size; trying to assign children who have missed or will miss a class to an alternative day/time will disrupt the rhythm, pace and integrity of that class. Further, we have found it is not practical to hold an additional class given the variance in lesson days, times and the abilities of our students. A pass to an open family swim will be given to those that cancel lessons in advance- not just missed,

8. When Parent or Guardian Must be Present. Child(ren) that have not yet developed appropriate behavior around a pool and understand and take direction from instructors should not be enrolled in lessons without a parent or guardian's presence at all times. Due to the nature of the activity engaged in by StarFish Swim School, StarFish expects that you will advise us of any special needs you're your child(ren) may require, including but not limited to Attention Deficit Disorder (**ADD**), seizures, asthma, motor skill delays, etc. in order to allow StarFish Swim School to determine whether swimming lessons are suitable activity for your child. When one child requires all an instructor's time and attention, this hinders other students in the class from learning and invariably results in complaints. Accordingly, Starfish reserves the right during the course of any class session, to terminate your child(ren) enrollment and/or make an alternative arrangement when possible (additional charges may apply).

9. Telephone Authorization. A telephone authorization is done to verify placement of a child into a class during registration. The date, time and name of the person with whom the authorization is made are written onto the registration form by the Swim School staff. The phone call and acceptance of the class time constitutes a binding agreement to pay for lessons whether in full or by half payment. If you realize that it becomes necessary to change the day or time, you are required to let the staff know before the start of the first missed class.

10. Starfish Swim School will prorate lessons when you begin lessons after the first week of a month.

11. Your signature is your acknowledgement that you have read this document or had the opportunity to read this agreement; that you have had an opportunity to ask questions before signing and that this document constitutes a fair and binding Agreement.
